



## Owners Invitational

Hosted by North Country Marine

Lake Sakakawea | Fort Stevenson Ramp | September 24, 2022

### PARTICIPANTS AND ELIGIBILITY

- Each team must complete an entry form and send it no later than Sept 19th. If you plan to enter the tournament after this date you must bring the entry form and check to the rules meeting Sept 23<sup>rd</sup> at the Garrison City Auditorium. Each team must pay to guarantee your spot.
- Each two or three person team must have one member at least 18 years of age.
- Anyone over the age of 16 must possess a current ND fishing license.
- Two or three person teams allowed. Maximum four (4) rods and the 10/5 fish rule applies.
- YC/NCM tournament committee has the right to refuse an entry by any team that does not abide by the rules set forth by NDG&F and YC/NCM.
- All NDG&F rules and regulations apply to this tournament.
- The first 100 teams to enter, with a \$300 entry fee, will be allowed to participate. Any team that signs up after the 100 team field is full, will go on a waiting list.

### WALLEYE SCORING

- Only Walleye will be weighed.
- Each team can have 10 walleye in the boat and weigh the best 5. You must have the best 5 ready to weigh before you get to the ramp. Culling is NOT allowed.
- A minimum length of 15" will be enforced.
- Payouts will be based on the number of teams entered into the tournament. 85% of all entries will be paid back to the top 5 teams if there are under 70 teams, and top 10 teams if there are over 70 teams participating.
- \*Walleye may be dead, but a member of YC/NCM can deny any fish they deem not to be caught that day.
- Tie breakers will be given to the team with the biggest fish and if neither team had a big fish they can split the 2 prizes.

- \*Teams 5 minutes late will forfeit 50% of their total weight and be disqualified if they are over 5 minutes late.
- If the tournament has to be canceled, each team will receive a refund of their entry fee.
- Any cheating will result in a life time ban from any YC/NCM events. The perpetrators names will be released to the NDG&F.
- By submitting your entry fee you consent to a post-tournament polygraph test.

## TOURNAMENT REGISTRATION AND RULES MEETING

- Garrison City Auditorium, Sept. 23rd beginning at 5pm. Food will be provided and drinks available courtesy of Hometown Tavern & Bottleshop.
- Payouts will be based on the number of teams entered into the tournament. 85% of all entries will be paid back to the top 25% of the field.
- Completed registrations must be turned in and/or received by mail by 6pm the night before the event.

## TOURNAMENT FORMAT

- Boat check-in begins a 6:30am at Fort Stevenson State Park.
- All boats must be returned to the ramp by 3:00 pm.
- No one can contact any other boat during tournament hours, nor can they go to shore for any reason besides an emergency or inclement weather.
- Marine band radios are encouraged to be used by all fishermen for emergencies. All the officials will be on channel 16. All emergency contact cell phone numbers will be given out at the rules meeting.
- Life jackets must be worn when the main engine is running
